#### **ANNUAL REPORT OF HON TREASURER 1998**

The Fund did not make any grants or loans during the year and has continued to grow steadily, primarily through interest received. Other income represents a small sum from NCA sales. Sales of the Hidden Earth '97 poster have been minimal and it seems unlikely that enough funds will be raised to repay the personal loan made covering production costs. Suggestion as to more successful means of raising funds are welcome.

Discussions on operation of the Fund were held with Bill Tolfree who was reviewing various financial matters on behalf of BCRA. Some concern had been expressed that the best rate of interest was not being obtained. It did appear that a higher rate could be obtained by moving the funds, however due to rapidly changing rates there is currently very little difference with interest offered by Abbey National. The situation will be reviewed later in the year.

The other main point covered was publicity. Some felt that the Fund should be better promoted. There was discussion on this both at NCA Conservation & Access Committee and National Council meetings. General feeling was that the Fund was adequately promoted at the moment. It is also felt that the size of the Fund needs to be increased at least twofold to be of any real use.

There was one change to the committee with the election of Elsie Little to take the place of Bill Gascoine; and Pete Mellors was reelected for a further term.
